1. Definitions used

Personal data - any information that allows you to directly or indirectly identify an individual, including data collected through the Form: name, phone number, as well as e-mail address;

2. Who is responsible for processing your Personal Data?

4. On what terms do we process your Personal Data?

We process your Personal Data that you enter into the Form for the purpose of:

- a) contacting you in order to exchange information to facilitate an assessment as to the possibility of a partnership between the Televisor Group company or companies and you or the company you represent the legal basis for the processing is your voluntary consent (Article 6(1)(a) of the RODO), until you withdraw it, which does not affect the lawfulness of the processing we performed prior to your withdrawal.
- b) receiving and processing any complaints related to the Form, where by submitting a request you agree to the processing of your Personal Data (Article 6(1)(a) of the RODO); we may process this data for a period of one year after responding, and thereafter for the period of the statute of limitations for claims,
- c) defense against possible claims the legal basis for the processing is then our legitimate interest (Article 6(1)(f) RODO), related to the protection of our rights in connection with your use of the Form.

5. Do you have an obligation to provide Personal Data?

The use of the Form and the related provision of Personal Data is voluntary. However, failure to provide Personal Data will prevent us from contacting you.

6. Who has access to your Personal Information?

We strive to keep access to the Personal Data you enter into the Form to a minimum. As a general rule, we do not transfer your Personal Data to other parties.

Your Personal Data will be accessed by our employees and associates whose job it is to contact you. In addition, this access may also be provided to IT systems and service providers or other entities that provide services to the Administrator consistent with the purpose of the Form.

For legitimate cases (e.g., defense against claims), your Personal Data may be shared with law firms, as well as other consulting companies.

Your Personal Data may also be transferred to entities authorized to do so by law.

We use appropriate technical, organizational and IT safeguards when processing your Personal Data, and periodically perform a risk analysis to ensure that your Personal Data is processed securely.

7. Do we transfer your Personal Data to third countries or international organizations?

Your Personal Data will not be transferred by us to third countries or international organizations.

8. Do we perform profiling?

We will not make any decisions based solely on automated processing, including profiling, that would produce legal effects against you or similarly affect you.

9. How long do we have access to your Personal Information?

We may process your Personal Data for up to five years from the end of the year in which you entered it into the Form.

We may also process your Personal Data for a longer period if further processing is necessary and permitted by

10. What rights do you have in connection with the processing of your Personal Data?

You are entitled to your rights:

- a) to access to and obtain copies of your Personal Data if you request it, we will provide you with information about our processing of your Personal Data, as well as copies of such data;
- b) to rectify your Personal Data if your Personal Data is not accurate, we will promptly rectify it upon your request;
- c) to delete of your Personal Data (,,right to be forgotten") you have the right to request us to delete your Personal Data, and we will delete it immediately, as long as there are no legal counter-indications;
- d) to withdraw your consent to the processing of your Personal Data you have the right to withdraw the consents you have given at any time, without affecting the lawfulness of the processing performed before their withdrawal;
- e) to restrict the processing of your Personal Data you have this right, for example, if you question the accuracy of your Personal Data (once we receive a notification from you, the processing of your Personal Data will be restricted until the matter is clarified);
- f) to portability of your Personal Data you have the right to receive from us the Personal Data you have provided to us, in the appropriate format provided by law; or you may choose to have your Personal Data transferred directly to another controller;
- g) to object to the processing of your Personal Data you have the right to object to the processing of your Personal Data if we process it based on our legitimate interest;
- h) not to be subject to profiling and automated decision-making you have the right not to be subject to a decision that is based solely on automated processing, including profiling, and produces legal effects on you or similarly affects you in a material way.
